## Terms of Conditions (T.O.C)

1. Any damage to our equipment must be paid for within 7 days.
2. If any mobile dj event needs to go longer then 5 hours it will be a fee of \$30 per hour . We will do party's up till 6 am if required. Any Overtime must be told about 24 hours prior to the event.
3. Any Extra Overtime required and wasn't told about 24 hour's prior to the event will be a fee of \$50 per hour. (Instead of \$30 per hour Pre-booked Overtime)
4. We provide everything which is on our Plans. Dance Party Hire will also provide for each event 1x Table, Smoke Machine Fluid, Bubble Machine Fluid, Spare Leads + Connections, Extension Cords + Power Packs, Microphone, Distribution Amplifier, Spare Light Globes & Request List.
5. Club DJ's time limit is 2 hours, their set can be extended which varies depending on the DJ.
6. Our Business Cards or Flyers will be on our Table so we can advertise ourselves.
7. If wanting to Request tracks for the Mobile DJ to get for your event please email them at least 3 days before the event.
8. Request List is available at all Mobile DJ events.
9. A \$50 Deposit must be paid at least 5 days before the event.
10. Full Refunds only if we can't Attend Your Event, Which has never happened.
11. Travelling Fee is \$1.50 per 1 Km, only applies when 10 km out of Marsden Park. Extra Travelling Fee's may apply to cover for tolls. Travelling distance charged only for driving their, not back.
12. We set up 1 to 2 + Hours before the event time starts & we pack up after your event time is finished.
13. If Hiring a Bubble Machine Beware Surface Becomes Slippery, So Please Think About Any Risk's Before Hiring a Bubble Machine.
14. We Don't Take Responsibility for Any Injuries.
15. To Book us: Online Booking Form to be filled out
16. A \$50 Deposit Must Be Paid to Secure the Day & Payment Amount for your Event.
17. Any Price Increase will not affect your Payment Amount if you have made the Deposit for your Event.

18. We Accept Bank Deposits, Money Orders, Paypal & Cash.
19. Once Deposit / Payment have been completed we will give you a Receipt at your Event.
20. Deposits are Not Refunded, but we will be Happy to Change the Date of Your Party if it is cancelled.
21. 50 % fee Increase if you Book your event on the Day of the Event, Please Pre-book Events in Advance (1 week - 3 months would be suitable)
22. If anyone who is attending your event has epilepsy, we will need to be notified not to use our strobe as it can trigger an epileptic fit
23. Easter, Christmas Day, New Years Eve & New Years Day Charges 2 to 4 Times the Amount to Book on any plans or equipment.
24. Outdoor Event's Must Provide Undercover Coverage to Prevent Any Rain from Damaging Our Equipment. If it Rain's once we get their and you don't Provide any Undercover Area for all off our Equipment, we will charge you the Travelling Fee's and 50 Percent off the quoted Price or if it Rain's during the Event and there is no Undercover Protection we will have to Pack Up, and Charge you the Full Price + Any Damages done to our Equipment.
25. Only a Max of 2 Request per Person allowed during the Event. No Exemptions as we are NOT a Human Juke box.
26. We don't Play any Request for Any Guest which is Rude / Arrogant or want there Song Jumped in the Requested Cue before the other Guest.
27. If you don't pay your full payment after we set up we will not turn our amplifiers on until we have recieved the full payment.
28. We don't book anyone's Event in if they refuse to Agree to our T.O.C on the Bookings Form or try and lower our Price's unless it's a School Disco with a small attendance for their event. As you won't find anyone with a better service, experience, equipment & dedication for the Price we charge.
29. If any guest or children touches our equipment including the smoke machine whilst at your event, we will ask them nicely to stop touching the equipment so we can prevent damage's and injuries . Once we have told them and if they do decide to continue we will turn the Music Off until the problem has been resolved if unresolvable from the client & their guest we will consider packing up early.
30. No drinks or food is allowed on or near any equipment including the DJ table.
31. No guest allowed behind the DJ table, client's are allowed behind if required.
32. We are not responsible for childrens actions and warn the parents to watch them around equipment as certain equipment like the smoke machine which can cause serious injuries if touched.
